1. Trip Permission Form (separate form)

The BHS chorus will be going to First United Methodist Church of Lawrenceville on **March 7 or 8, 2023**, to sing in the Georgia Music Educators Association Large Group Performance Evaluation (LGPE). This event is sponsored by the Georgia Music Educators Association (GMEA). Parents are welcome to attend our performance. All Chorus students have prepared since August to sing in this performance, and I would like for all students to participate. Performance in this event is a required test grade. In addition, students must achieve satisfactory sight-reading & repertoire progress to be permitted to participate. **Behavior/lack of engagement contrary to successful choral rehearsal and/or performance will result in removal from the trip at the director's discretion.** Student who are removed from the trip will be offered a substitute assignment for this test grade.

2nd & 3rd Period Chorus – March 7

On March 7, 2023, BHS Treble Chorus (2nd & 3rd period) will perform at LGPE. Meet in the chorus room, **dressed in concert attire**, at 9:22am for warm-up. This is the start of the 5th period Milestone testing time. You will schedule a time with your teacher to make up that 5th period test if necessary. Check with your 5th period teacher. (Tested classes include Algebra I, Biology, US History (non-AP), 11th Grade Am. Lit & Comp classes only during 5th period) We depart for LGPE promptly at 10:10am, and perform at 11:20am. We will return around 12:25pm. You will then eat lunch during 6th period lunch and go to your 7th period class like normal.

4th Period Chorus – March 7

On March 7, 2023, BHS Cantabile (4th periods) will perform at LGPE. Meet in the chorus room, **dressed in concert attire**, at **2:20pm** for warm-up. We depart for LGPE promptly at 2:50pm and perform at 4:40pm. We will return around 5:40pm. **You will need a ride home that evening.**

4th & 5th Period Chorus – March 8

On March 8, 2023, BHS Mixed Chorus (4th & 5th periods) and BHS Forte (5th Period) perform at LGPE. If you do not have 4th or 5th period lunch, you will need to eat lunch during 5th period. Meet in the chorus room at 12:00pm **dressed in concert attire**. We depart for LGPE at 12:30pm. Forte Chorus performs at 1:40pm, and Mixed Chorus performs at 2:40pm. We will return to school around 3:40pm; **you will need a ride home that afternoon.**
